

10. FUNCTIONS & TERMS OF OFFICE BEARERS

The terms of office bearers of the Trust will be ordinarily for three years except the Founder cum-President who is called as lifelong Chief Functionary. In exceptional cases the Board of Trustees may extend it for another six months from the date of its expiry.

1. PRESIDENT

- vii) He is the custodian of cash and all other movable and immovable properties of the Trust. He shall manage all properties and incur all expenditures of the Trust according to the direction of the Board.
- viii) He has an authority to spend maximum up to Rs. 20,000/- only from the local fund of the Trust in case of emergency condition. The expenditure which is to be approved in the next Board Meeting.

2. SECRETARY

- i) No part of the Trust funds either the corpus or the income thereafter, shall be utilized for any purpose other than the object of the Trust hereby created and shall be utilized in India for the benefit of the public.
- ii) The founder Trustee or other Trustees in their resolutions shall not obtain any benefit whatsoever directly or indirectly from the income of the property of the Trust. However the Trustees shall, by entitled to draw a monthly salary and other perquisites as may be decided by the Trustees from time to time for the service rendered to the organisation.

17. FINANCIAL TRANSACTION OF THE TRUST

Bank Accounts of the Trust shall be maintained in any Nationalized Bank or Private bank or scheduled bank with cheque facility which will be operated jointly by the President and Secretary or Treasurer or any authorized person approved by trustees in Board Meeting through resolution. The signature of the President in case of withdrawal of any amount from in Bank is mandatory. The President, Secretary, Treasurer may be allowed for contingent amount by way of impressed to meet day to day expenditure of the Trust as may be delegated to them by the Board Trustees.

18. AUDIT AND ACCOUNTS

Regular books of accounts of the Trust shall be maintained and a Chartered Accountant or firm of Chartered Accountants selected by the Board of Trustees shall audit the same annually. Accounting year of the Trust shall be from 1st April to 31st March.

19. REMUNERATION OF TRUSTEES

- a. The Trustees shall not be entitled to any remuneration for service rendered provided however, any service rendered by them in their professional capacity shall be remunerated in the normal course.
- b. The funds of income of the Trust shall not be directly or indirectly made available to the author of the Trust or other

prohibited category of persons mentioned in the income Tax Act. 1961, so as to directly or indirectly benefit such persons referred therein excepting for reasonable remuneration for services rendered.

20. LIABILITY OF TRUSTEES

The Trustees shall not be liable for any loss that may be caused to the Trust funds, unless the Trustees are found guilty of fraud or criminal breach of Trust by competent Court of Law, likewise the private liabilities of the Trustees shall not affect the Trust.

21. INDEMNITY

Every Trustee for the time being, shall be indemnified out of the assets of the Trust, Funds against any liability incurred by his/her in any proceedings either civil or criminal, in which the judgment is given against his/her favor or in which he/she is convicted, provided the said proceedings relate to any matter arising out of the administration of any act or deed done by him/her.

22. AMENDMENT OF THE TRUST DEED

The Trust deed may be amended by a resolution passed by a majority of Trustees not less than two third of the Trustees present and voting in the meeting of the Board of Trustees called for the purpose of amendment and any change of rules and regulation of the Trust. The Secretary shall circulate such an act of amendment proposed and seconded by a Trustee for the amendment of the Trust deed to all the members of the Board of Trustees at least 7 days prior to the meeting of the Board of Trustees.

23. REGISTRATION :

The Trust shall be registered with Income Tax Act U/s 12 (A) and 80 (G) and FCRA.Act. and other Act for the purpose of achievement of the objective of the Trust.

24. DISSOLUTION

In the event of Dissolution of the Trust, the properties and funds remaining shall be transferred or paid to some other Trust or Institution having similar objects or any other registered society with similar objects or dissolved as per law.
